CASE MANAGEMENT ORDER # 21
(Defendants' Corporate Disclosure Statements)

I. PURPOSE OF THIS ORDER

This Order is intended to conserve judicial and party resources and promote the just and efficient conduct of this litigation by streamlining the process for certain required filings. This Case Management Order shall apply to all cases in MDL 2750.

II. FILING OF DEFENDANTS' CORPORATE DISCLOSURE STATEMENTS

These matters, having been transferred to this Court by order of the Judicial Panel on Multidistrict Litigation pursuant to its order of December 7, 2016; and it appearing that Defendants Janssen Pharmaceuticals, Inc., Johnson & Johnson, Janssen Research & Development, LLC, and Janssen Ortho LLC previously filed Corporate Disclosure Statements before the Judicial Panel on Multidistrict Litigation on October 5, 2016; and for good cause shown, it is hereby ORDERED:

A. Within seven (7) days of entry of this Order, Defendants Janssen Pharmaceuticals, Inc., Johnson & Johnson, Janssen Research & Development, LLC, and Janssen Ortho LLC shall electronically file a Corporate Disclosure Statement pursuant to Federal Rule of Civil Procedure 7.1 on Master Docket No. 3:16-md-2750;

B. Defendants' Corporate Disclosure Statement electronically filed on Master Docket No. 3:16-md-2750 shall apply to all cases currently pending in the MDL and all cases filed in, transferred to, or removed to the MDL following entry of this Order, such that Defendants will not be required to file separate Corporate Disclosure Statements for each individual case in MDL 2750;

C. Pursuant to Federal Rule of Civil Procedure 7.1, Defendants shall promptly file a supplemental Corporate Disclosure Statement on Master Docket No. 3:16-md-2750 if any required information changes, which shall apply to all cases currently pending in the MDL and all cases filed in, transferred to, or removed to the MDL following entry of this Order; and

D. The Clerk of the Court is hereby instructed to cease issuing ECF docket notices pertaining to the requirement to file a Corporate Disclosure Statement upon the filing of a Notice of Answer and Affirmative Defenses in each individual case in MDL 2750. This instruction shall apply to each case currently pending in the MDL and for all cases filed in, transferred to, or removed to the MDL following entry of this Order, until such time as those cases are no longer associated with MDL 2750, including remand, or as otherwise ordered by the Court.
