

IT IS HEREBY FURTHER ORDERED that Plaintiffs shall validly serve upon the Japanese Defendant, Daichii Sankyo Company, Ltd., one complaint in accordance with the Hague Convention requirements. Thereafter, with said Defendant's consent, Defendant will not object to service on it by certified mail in the remaining cases in this multidistrict litigation.

IT IS HEREBY FURTHER ORDERED that discovery undertaken in the New Jersey state court proceedings may be used in this multidistrict litigation. Any depositions taken should be coordinated between the litigations so that a witness may only be deposed once, unless the parties otherwise agree or the Court otherwise grants an exception.

IT IS HEREBY FURTHER ORDERED that Plaintiffs shall choose a document repository by the next status conference on June 30, 2015.

IT IS HEREBY FURTHER ORDERED that Plaintiffs and Defendants shall each file a brief with the Court regarding issues relating to a Discovery Confidentiality Order by **June 1, 2015**. The parties shall file their opposition papers with the Court by **June 8, 2015**.

IT IS HEREBY FURTHER ORDERED that by **Friday, May 22, 2015**, Plaintiffs shall serve Defendants with a definitive list of any issues they want to address related to an Electronically Stored Information ("ESI") protocol. Plaintiffs and Defendants, along with their respective ESI consultants, shall conduct an in-person meeting no later than **Friday, June 5, 2015**. Plaintiffs and Defendants shall each file a letter brief with the Court regarding any unresolved ESI issues or disputes by **June 18, 2015**. The parties shall file their opposition papers with the Court by **June 25, 2015**. Oral Argument will take place on **Tuesday, June 30, 2015 at 10:00 A.M.** before Judge Schneider in Courtroom 3C of the Mitchell H. Cohen United States Courthouse, 1 John F. Gerry Plaza, Camden, N.J. 08101. The parties' ESI consultants shall appear in-person unless otherwise ordered by the Court.

IT IS HEREBY FURTHER ORDERED that the next status conference will take place on **Tuesday, June 30, 2015, at 2:00 P.M.** in Courtroom 4D of the Mitchell H. Cohen United States Courthouse, 1 John F. Gerry Plaza, Camden, N.J. 08101.

IT IS HEREBY FURTHER ORDERED that the following status conference will take place on **Tuesday, July 21, 2015 at 2:00 P.M.** in Courtroom 4D of the Mitchell H. Cohen United States Courthouse, 1 John F. Gerry Plaza, Camden, N.J. 08101.

IT IS HEREBY FURTHER ORDERED that the status conference after that will take place on **Wednesday, September 2, 2015 at 2:00 P.M.** in Courtroom 4D of the Mitchell H. Cohen United States Courthouse, 1 John F. Gerry Plaza, Camden, N.J. 08101.

IT IS HEREBY FURTHER ORDERED that monthly status conferences will resume on **Wednesday, September 30, 2015 at 2:00 P.M.**, and shall thereafter take place on the last Wednesday of each following month at 2:00 P.M. in Courtroom 4D of the Mitchell H. Cohen United States Courthouse, 1 John F. Gerry Plaza, Camden, N.J. 08101, unless the parties are otherwise notified by the Court.

IT IS HEREBY FURTHER ORDERED that by **June 26, 2015**, the parties shall file a joint letter with a proposed agenda for the June 30, 2015 conference with the positions of the parties on the issues in dispute.
