Dear Prospective CJA Panel Member:

On August 22, 2018, the Judicial Council of the Third Circuit adopted the current Criminal Justice Act (CJA) Plan for the District of New Jersey. The Plan requires an application and appointment process for <u>all</u> those seeking membership on the CJA panel. Pursuant to the Plan, "membership on the CJA Panel is ordinarily for a term of three years. Presumptively, a panel member will serve no more than two consecutive terms." The Plan also establishes a Training Panel. *See* Criminal Justice Act Plan, Sections IX(C)(6)(7), VIII(C)(1).

With regards to eligibility, the Plan provides: (a) "Applicants must be in good standing of the federal bar of this District and the Third Circuit Court of Appeals. (b) Applicants must maintain a primary, satellite, or shared office in this District. (c) Applicants must possess strong litigation skills and demonstrate proficiency with the federal sentencing guidelines, federal sentencing procedures, the Bail Reform Act, the Federal Rules of Criminal Procedure, and the Federal Rules of Evidence. (d) Applicants must have significant experience representing persons charged with serious criminal offenses and demonstrate a commitment to the defense of people who lack financial means to hire an attorney. (e) Attorneys who do not possess the experience set forth above but believe they have equivalent other experience are encouraged to apply and set forth in writing the details of that experience for the CJA Committee's consideration."

Attorneys seeking membership on the CJA Panel who need experience to meet the eligibility requirements outlined in the Criminal Justice Act Plan, Section IX (C)(3), may pursue membership on the CJA Training Panel. The CJA Training Panel has been established to, "increase diversity and ensure the availability of qualified applicants to the CJA Panel by providing attorneys who do not have the required experience for membership on the CJA Panel with an opportunity to gain the experience necessary to provide high quality representation in federal criminal cases..." See Criminal Justice Act Plan, Section VIII(C). If you are seeking appointment to the CJA Training Panel and a current CJA Panel member has agreed to act as a mentor for you, please provide their name and phone number on the application.

The Court will begin accepting applications to the Criminal Justice Act Panels for the District of New Jersey beginning December 05, 2022 (see "Notice to the Bar").

You may apply for appointment to the CJA Panel or the CJA Training Panel by completing and submitting the application in PDF format to William T. Walsh, Clerk, United States District Court, via e-mail at njcja@njd.uscourts.gov on or before January 06, 2023.
