**THIS ORDER** is a companion Order to the Court’s Order of June 29, 2015, wherein the Court, with the consent of legal counsel for both the Plaintiffs and the Defendant agreed upon a schedule for the deposition of fourteen (14) Plaintiffs, one of whom is the Plaintiff, Channie Carpenter (ATL-L-3160-14), a resident of the State of Louisiana who elected to commence suit in the State of New Jersey; and, thus far, there having been difficulty arriving at a date for the taking of Ms. Carpenter’s deposition; and the court being apprised that Ms. Carpenter’s attorneys, to wit, Rayna E. Kessler, Esquire, and Peter C. Snowdon, Esquire, have moved to be relieved as counsel – with the apparent knowledge and consent of Ms. Carpenter – and said Order to be entered in the near future; and it being important to the proper handling and administration of the within litigation that all of the aforementioned 14 depositions occur; and the court being mindful of Ms. Carpenter’s need to retain substitute legal counsel for Ms. Kessler and Mr. Snowdon; and for good cause shown;

**IT IS** on this 29<sup>th</sup> day of June, 2015, **ORDERED**, that the deposition of Plaintiff, Channie Carpenter, a resident of the State of Louisiana, shall and must occur on or before October 30, 2015. [NOTE: Ms. Carpenter and her legal counsel may select any one of the five weekdays during the week of October 26, 2015, to wit, October 26, 27, 29, 29, or 30, 2015;

**IT IS FUTHER ORDERED** that Ms. Carpenter’s substituted legal counsel shall promptly contact Daniel B. Carroll, Esquire of the Drinker, Biddle & Reath Law Firm and make arrangements for the scheduling of Ms. Carpenter’s deposition during the week of October 26, 2015, but in no event later than October 30, 2015. Said deposition shall occur at the Defendant’s counsel’s law offices of Drinker, Biddle & Reath, in Florham Park, New Jersey.

**IT IS FURTHER ORDERED** that in the event Plaintiff, Channie Carpenter fails to present herself for her deposition on or before October 30, 2015, her Complaint shall be DISMISSED WITH PREJUDICE, upon submission of an appropriate Order by Mr. Carroll.

**IT IS FURTHER ORDERED** that this Order as well as the companion Order of even date herewith shall be personally served upon Plaintiff, Channie Carpenter, on or before July 6, 2015.
