## **NOTICE TO THE PUBLIC**

### **U.S. District Court for the District of New Jersey Announces Visitor Restrictions**

The United States District Court for the District of New Jersey announces visitor restrictions to all courthouses in the District as a result of the COVID-19 virus (coronavirus) outbreak in New Jersey.

The Centers for Disease Control has advised people to take precautions in light of the COVID-19 virus outbreak and noted that the best way to prevent illness is to avoid being exposed to this virus. Therefore, effective immediately, the following persons shall not enter any courthouse in the District of New Jersey:

- Persons who have been diagnosed with, or have had contact with anyone who has been diagnosed with, COVID-19
- Persons who have been asked to self-quarantine by any doctor, hospital or health agency
- Persons who have travelled to any of the following countries within the last 14 days:

CHINA  
JAPAN  
IRAN

SOUTH KOREA  
ITALY

(This list may be updated as further guidance is received.)

- Persons who reside or have had close contact with someone who has travelled to one of the countries listed above within the last 14 days or reside or have had close contact with someone who has been asked to self-quarantine.

Visitors to the Courthouses are directed to report any of the above possible exposure to COVID-19 to the Court Security Officer at the Screening area before entering the Courthouse.

**Anyone attempting to enter in violation of these protocols will be denied entry by a Court Security Officer.**

If you have a scheduled appointment or you are otherwise required to appear at one of the courthouses in the District of New Jersey and you are unable to appear because of the restrictions listed above, you should proceed as follows:

- If you are represented by an attorney, please contact your attorney.
- If you are an attorney and you are scheduled to appear in court before a judge, please contact that chambers directly (contact information may be found on this website under Our Judges>Judicial Preferences).
- If you are scheduled to meet with a Pretrial Services officer, please contact the office of Pretrial Services for your vicinage. Camden: 856-757-5107; Newark: 973-645-2230; Trenton: 609-989-2056
- If you are scheduled to meet with a Probation officer, please contact the Probation office for your vicinage. Camden: 856-757-5043; Newark: 973-645-4240; Trenton: 609-989-2071

These restrictions will remain in place until it is determined to be safe to remove them. People who think they may have been exposed to COVID-19 should contact their healthcare provider immediately.
