CASE MANAGEMENT ORDER NO. 14
(Notices of Appearance; Answers)

I. PURPOSE OF THIS ORDER

This Order is intended to conserve judicial and party resources and promote the just and efficient conduct of this litigation by streamlining the process for certain pleadings. This Case Management Order shall apply to all cases in MDL 2750.

II. NOTICES OF APPEARANCES

For all cases currently pending in the MDL and for all cases filed in, transferred, or removed to the MDL following entry of this Order, the clerk is instructed to associate the following counsel as counsel of record for Janssen Pharmaceuticals, Inc., Johnson & Johnson, Janssen Research & Development, LLC, and Janssen Ortho LLC as named in the respective complaints:

III. FILING OF ANSWERS

To improve the efficient management of pleadings in this litigation, it is hereby ORDERED:

A. All motions to dismiss in cases currently pending in the MDL, that were not previously withdrawn, are deemed withdrawn as of the date of this Order. The cases in which motions to dismiss are pending are listed in the attached **Exhibit A**. By withdrawing these motions, Defendants waive no pre-answer defenses raised in those motions and expressly reserve their right to raise those defenses in answering plaintiffs' complaints.

B. For all cases currently pending in the MDL for which service has been effected on some or all Defendants and no answer has been filed, within thirty (30) days of entry of this Order, served Defendants shall file a Notice of Answer and Affirmative Defenses in each case.

C. For all cases filed in, transferred or removed to the MDL following the date of this Order, Defendants shall have twenty-one (21) days after service if no waiver of service is requested or thirty (30) days after execution of a waiver to file a Notice of Answer and Affirmative Defenses.

D. The Notice of Answer and Affirmative Defenses shall provide a general denial to plaintiffs' allegations in the Complaint and assert applicable affirmative defenses and will constitute an answer for purposes of Rules 7 and 8 of the Federal Rules of Civil Procedure.

E. Defendants reserve the right to file an answer specifically answering plaintiffs' allegations and raising any additional affirmative defenses later in the proceedings as cases are either remanded or designated for bellwether discovery.

F. Defendants shall interpose full Answers within fourteen (14) days of the selection of a given case in the bellwether process. As such in accordance with CMO 10, it is presently contemplated that Answers in the bellwether cases shall be due on or about September 7, 2017.


