This matter having been resolved, in part, through the efforts of all parties; the Court having entered Administrative Order No. 1 on August 16, 2018 (ECF No. 270), Administrative Order No. 2 on April 3, 2019 (ECF No. 283), Administrative Order No. 3 on July 24, 2019 (ECF No. 295), Administrative Order No. 4 on August 5, 2019 (ECF No. 298), Administrative Order No. 5 on October 24, 2019 (ECF No. 311), Administrative Order No. 6 on October 30, 2019, Administrative Order No. 7 on November 13, 2019 (ECF No. 317), Administrative Order No. 8 on February 16, 2022 (ECF No. 335), Administrative Order No. 9 on May 5, 2022 (ECF No. 338); Administrative Order No. 10 on June 8, 2022 (ECF No. 340); and Administrative Order No. 11 on July 26, 2022 (ECF No. 342), and counsel and the parties having substantially complied with the terms therein; the vast majority of matters having been resolved and/or dismissed; the Court having previously ordered that the cases listed on Exhibit A to Administrative Order No. 9 (ECF No. 338-1) be dismissed without prejudice, and that, on July 15, 2022, the dismissals were converted to dismissals with prejudice; and for good cause shown,

**IT IS** on this 20th day of September 2022,

**ORDERED** that based on discovery deficiencies the following cases have been dismissed with prejudice:
